Managers Meeting

ALL TEAM MANAGERS: PLEASE ARRIVE BY 8:00 AM FOR A MANAGER'S MEETING

1. 8:00 AM – Manager's meeting: Race course, marshalling and loading procedure, protest procedures, *hand-in completed signed waiver if not already submitted.*

Please Note: All paddlers must be covered by CKBC or applicable paddling insurance in order to participate in the 2011 Lotus Dragon Boat Regatta.

- 2. For the remaining races of the day, see Bulletin Board for race in progress and number loading.
- 3. Please have your entire team report to the boats when you see your race number loading. It is your responsibility to keep track of the Bulletin Board.
- 4. Team pictures will be taken at the marshalling area prior to your team's first race. Race times for the first few heats will be extended slightly to allow for this. A framed photo will be presented to each team as a race souvenir at the conclusion of the event.

Pre-Race Information

Please make sure your team is ready for loading 15 minutes prior to the scheduled race start time. Check the boards for updates and delays.

Start Commands

- 1. "Paddles up"
- 2. "Attention Please"
- 3. Air horn blast boats may start



If, after 2 warnings, your boat is not at the start line by the time the Starter is ready to commence, the race will begin no matter where your boat is positioned.

Rules

Team Composition

Women's Teams

- The team must be comprised of all women.
- Steersperson and drummer can be either male or female.

Mixed Adult Teams

- The team must have <u>at least 8 female paddlers</u>. The balance of the crew can be either gender.
- Steersperson and drummer may be of either gender.

Senior Master Teams

- The team must have <u>at least 8 female paddlers</u>, The balance of the crew can be either gender.
- Steersperson and drummer may be of either gender.
- Paddlers must be 55 years of age and older (drummer and steersperson excluded).

Junior Teams

- All members of a junior team must be at least 13 years of age, and no older than 19 by the race date.
- The team must have <u>at least 8 female paddlers</u>, the balance of the crew can be either gender.
- Junior paddlers require their <u>parent's or guardian's consent</u> (Page 13) in order to participate.

Re-Race Rules

At the Officials' discretion, a re-race may be ordered when:

- There is a false start called by the Starter, or
- There is clearly a collision within the first 50 metres of the race, or
- There is an equipment breakage, other than paddle, within the first 50 metres of the race

There are absolutely no grounds for re-races after all boats have passed the 50 metre mark, except if initiated by the Officials under extraordinary circumstances.

Equipment

- All participants are required to wear a PFD while in the dragon boat. Approved PFD's will be provided, but paddlers and teams are encouraged to bring their own PFDs.
- Competitors are encouraged to use their own PFDs provided they are approved by the Department of Transport, the Canadian Coast Guard, or the Department of Fisheries and Oceans.
- Competitors may use their own wood, composite or carbon fiber paddles provided the paddles conform to the IDBF racing paddle specification sizes. Regulation sized paddles will be provided, but paddlers and teams are encouraged to bring their own paddles.

Water Safety Rules - Capsizing, Crew Overboard

- Should a boat capsize, the crew must remain with their boat, take a head-count and await rescue.
 - Confirm that PFDs are properly fastened.
 - Remain with the boat. Do not attempt to swim to shore.
 - Other boats must stay clear of the area and allow motorized rescue and recovery craft room to manoeuvre.
- In the event that any crew member goes overboard, the dragon boat must stop immediately without turning into the path of any oncoming boats in adjacent lanes.
- Should the steersperson go overboard, the drummer must take command of the boat and bring it to an immediate stop.

Race Day Suggestions

- First aid attendants will be available during the regatta. However, we strongly recommend you have a team first aid kit made up and available.
- Bring a team canopy / tent.
- Come early to get a table under the trees by the beach
- Put together a team picnic. Please note that there will be no public access to electrical outlets.
- Be ready for all weather conditions

The Lotus Dragon Boat Regatta takes place in Barnet Marine Park in Burnaby.


Directions to Barnet Marine Park:

Going West on Barnet Highway, make a right on Takeda Drive. (There is a sign that says Barnet Marine Park, and a traffic light where you should turn right.) Turn right again and follow the road until you reach some parking lots. Walk down Takeda drive until you cross the railroad tracks.

Going East on Barnet Highway, make a left on Takeda Drive. Turn right and follow the road until you reach some parking lots. Walk down Takeda drive until you cross the railroad tracks.
